ENTRY

RESTRICTIONS:

1. No swimmer may enter more than four individual events
2. **No late entries will be accepted.**
3. **No Deck** entries.
4. No entries accepted without a current USS number.
5. Age of the swimmer on the first day of the meet determines eligibility.
6. Swimmers without a coach need to advise the Meet Director in advance. It is the responsibility of the club to have a coach for swimmers entered in the meet. It must be a registered coach and can be assigned from another team. This should be done in advance by contacting another coach attending the meet.
7. Any club who enters a swimmer that is not USA-Swimming registered member will be fined \$100.00.

PROGRAMS: Programs for the meet will be on sale.

CONDUCT: Proper conduct at all times will be enforced by Coaches , Meet Marshals and FAST parents. Swimmers found in restricted areas will be Disqualified from the remainder of the meet.

DECK ID: Only Swimmers, Coaches, Officials, and Meet personal allowed on deck.
Coaches must wear their USS ID NO EXCEPTIONS!
