- AWARDS: "G" Awards-Ribbons 1<sup>st</sup> – 6<sup>th</sup>; Individual Hi-Point Award - 1st Place  
"S" Awards- Ribbons 1<sup>st</sup> – 6<sup>th</sup>; Individual Hi-Point Award - 1st Place  
"B" Awards- Ribbons 1<sup>st</sup> – 6<sup>th</sup>; Individual Hi-Point Award - 1st Place  
Relay Events - Ribbons 1<sup>st</sup> – 3<sup>rd</sup>  
Team Trophies - 1<sup>st</sup> Place - Large Team (20 swimmers & over)  
- 1<sup>st</sup> Place - Small Team (under 20 swimmers)  
Awards to be picked up by Coach or an assigned adult representative.
- SCORING: Team scores will be kept with total points per event. (Including all points from "G" awards, "S" awards, and "B" awards.) Points scored as follows:  
Individual Events - 7, 5, 4, 3, 2, 1 for each segment of event (G, S, B)  
Relay Events - Points scored for first three relays only - 14, 10, 8  
**THIS IS A TIMED FINAL MEET**
- DECK ID: Coaches MUST wear their USS ID.
- DISCIPLINE: Proper conduct at all times will be enforced by parents, coaches, marshals, and Meet Director. Misconduct or vandalism will result in swimmer being expelled from the meet. **THERE WILL BE NO USE OF SLIDE AREA OR SPLASH PARK AREAS THANK YOU.**

- TIMERS: **Competing teams are welcome to volunteer timers .ALL 400 IM, 400 & 800 FREE YOU MUST SUPPLY TIMER & COUNTER (800 FREE)**
- OFFICIALS: Anyone interested in officiating, please contact Sue Seiler.
- REFRESHMENTS: Available at reasonable cost for the duration of the meet. Eating area is provided

- PROGRAMS: 3 day programs will be available for purchase at the meet.

- WADING POOL: Any parent wishing to use the wading pool for their younger children, while at the Meet, will be charged a fee (required by the Town of Cheektowaga) when entering the wading pool area. **This is a separate area and not considered part of the Meet. No meet swimmers are allowed in the wading pool.**
